

## **WEBSITE TERMS OF USE**

- 1. **Introduction.** Welcome to the America's Credit Union ("Credit Union") website. Your access to this site is subject to the following Terms of Use. By accessing and using this site, you accept these Terms of Use without limitation or qualification. You agree we may change these Terms of Use from time to time, by posting the revised Terms of Use to the website
- 2. **Web Content & Material.** Credit Union reserves the right, without notice and for any reason, to remove any content on this site, and to deny access to any user or users to all or any part of this site.
- 3. Your Enrollment and Contact Submissions. The Credit Union may provide financial services on this website that require your enrollment or submission of contact information. By enrolling in such services or making any applicable submissions, you expressly consent and authorize the Credit Union and its representatives to contact you by email, telephone (including cell phone), text message, or automated dialing communications at any number you provide the Credit Union for your accounts and services, now or in the future for purposes of assisting with your accounts and services or to prevent fraud on your account. No information will be disclosed or shared with third parties except as provided in our Privacy Policy.

You authorize your wireless operator (AT&T, T-Mobile, US Cellular, Verizon, or any other branded wireless operator) to disclose your mobile number, name, address, email, network status, customer type, customer role, billing type, mobile device identifiers (IMSI and IMEI) and other subscriber status and device details, if available, to our third party service provider, solely to verify your identity and prevent fraud for the duration of the business relationship. Our third-party service providers are bound by our data security and confidentiality requirements. See our Privacy Policy for how we protect your data.
- 5. Text (SMS/MMS) Notifications. The Credit Union may provide notification services that allow us to contact you by text (SMS/MMS) notices or alerts. By enrolling in such services, you expressly consent and authorize the Credit Union and its representatives to contact you via text message, including automated dialing communications at any number you provide, to provide you information alerts. Message frequency depends on account settings and conditions. You may Text "STOP" to opt-out or "HELP" for help at any time. You understand that message and data rates may apply to your use of the service and that the cellular provider is not responsible for delayed or undelivered messages.
